Dear Cat Trapper:

The enclosed **FSNP** (Feral Spay/Neuter Program) certificate is good for 1 free spay/neuter of a feral (wild, unfriendly, untamed) cat. This certificate must be used before the expiration date listed (typically 60 days), after which you must contact us to receive another certificate.

By using the FSNP certificate, you are implicitly agreeing to the following requirements:

- Cats under this program are feral and can not easily be handled.
- Cats will be allowed to recover from surgery for 24 to 48 hours in the cat trap. After which time, cats will be returned where they were trapped, provided no other medical conditions inhibit their release.
- Food and water must be provided to the cats after their release.
- The veterinarian will "tip" the right ear to indicate the feral cat has been altered.
- All cats will be trapped and cared for in a humane manner.

Upon trapping any feral cats, you must transport them individually in humane cat traps to one of the following vets. Using pet carriers or wire cages for transportation is not appropriate and may void the use of the certificate. **Never attempt to transfer a feral cat from a trap to some other carrier. The feral cat should remain in the trap during the recovery period (24 to 48 hours) until released. Cover the trap with a large towel or sheet to calm the cat while it is in the trap and place newspaper under the trap during transportation and the recovery period.**

Let the veterinarian know that you have an **FSNP** certificate and bring the enclosed FSNP certificate with you. The no-cost spay and neuter can only be performed with a valid **FSNP** certificate. The program covers basic spay or neuter surgery (including in-heat or pregnant females) as well as rabies and FVRCP vaccinations. No testing will be covered. Note that most veterinarians **may not** be able to do surgeries from Friday to Sunday, call ahead to verify.

Neither this program nor the vet is liable for any possible health complications arising from the surgery or due to pre-existing health problems of the cats. If a cat is ill, upon recommendation by the veterinarian, the cat will be euthanized at Folsom Feline Rescue's expense.

Thank you for working with us to stop the critical pet overpopulation problem in your area. You are doing a tremendous service to your community.
