Dear Pet Owner:

The enclosed SNYP (Spay/Neuter Your Pet) certificate is good for one free spay/neuter of a cat or dog. This certificate must be used before the expiration date listed (typically 60 days), after which you must contact us to receive another certificate. Please check the expiration date on the certificate.

Vaccinations

The participating veterinarians in this program require a minimum set of vaccinations before the surgery can be performed. If your pet is current on its vaccinations, **you must bring a vaccination history from your veterinarian.** You may want to contact your local pet or feed store to find out about low cost vaccination clinics. These vaccinations can given at the time of surgery if needed and **you will be responsible for covering the cost for these vaccines at the time of surgery.** If you cannot afford vaccinations and provided sufficient reason for needing assistance, your SNYP certificate(s) should have a *vaccination authorization sticker* applied to the top of the certificate(s). This indicates to the vet that Folsom Feline Rescue will cover the cost of vaccinations. If no sticker is present, you are responsible for providing proof of vaccinations or covering the cost at the time of surgery. ***Required vaccinations: Dogs (Rabies, Distemper), Cats (Rabies, FVRCP)***

Pregnancies

It is Folsom Feline Rescue's policy to abort all pregnancies at the time of the spay surgery if possible. We are dealing with a very serious population issue with cats and dogs. For every litter born and given a home, another litter of adoptable kittens and puppies will remain homeless and/or be euthanized. If this concerns you, discuss it with the veterinarian prior to your appointment. Once the spay/neuter surgery has begun, any pregnancies will be aborted. Animals that are in heat can still be spayed.

Let the veterinarian know that you have a SNYP certificate and **bring the certificate(s) with you at the time of surgery.** The no-cost spay/neuter can only be performed with a valid SNYP certificate. The spay/neuter certificate covers spay or neuter surgery (including in-heat or pregnant females). The vaccination certificate (if provided) covers rabies and distemper/parvo or FVRCP vaccinations. Any additional services requested are not covered under this program. **The certificate is null and void if declawing, tail docking, ear cropping, or any other mutilating procedure is performed at the time of the spaying and neutering.**

Neither this program nor the veterinarian is liable for any possible health complications arising from the surgery or due to pre-existing health problems of the pet. Vaccination history is required. Cats must be transported in a carrier and dogs must be on leashes. This program does not cover feral (wild) cats. If you have a feral cat, please contact Folsom Feline Rescue to obtain an FSNP (Feral Spay/Neuter Program) certificate.

Thank you for working with us to stop the critical pet overpopulation problem in your area. You are doing a tremendous service to your community.
